

Ultrasound International Open (UIO) is a peer-reviewed international open access journal that publishes original contributions reporting on new developments from a variety of disciplines on the diagnostic and therapeutic applications of ultrasound, with an emphasis on clinical application. Technical papers with a physiological theme as well as the interaction between ultrasound and biological systems are also accepted for publication. Only manuscripts written in English are considered. When submitted, manuscripts must not have been published elsewhere or be under simultaneous consideration by another journal. Original and review articles as well as rapid communications, contributions on technical developments, case reports and pictorial essays are welcome. Submission and additional publication of video material is possible. The editors decide upon acceptance, rejection or the

need for revision of submitted manuscripts. As a quarterly open-access publication, all content is freely available online to all readers.

Manuscript submissions are accepted exclusively online at <http://mc.manuscriptcentral.com/uio>. Manuscripts should be prepared according to the guidelines in the following table before submission. ² To activate the "Track Changes" function in Word, go to "Tools" → "Track Changes" → "Highlight Changes". Activate all check boxes in the "Highlight Changes" window.

Letters to the Editor are submitted via ScholarOne. Letters do not have an abstract and should not exceed 2500 words, including the references (if present). Letters should be provided with a proper title (e.g. "Letter to the Editor on the article [reference of article] ..."). The editors decide on publication of the letter and the authors' response (if applicable).

Article Processing Charges: You may be personally invited to publish in UIO or you have a submission voucher (please see homepage for further information) – in this case no article processing charge (APC) will be charged and you will be asked to fill in the code number when submitting your manuscript. An article processing charge (APC) will be charged for every accepted manuscript published in UIO. EUR 1,600 plus VAT are charged for original articles (incl. rapid communications), papers on technical development, and reviews; EUR 800 for case reports and pictorial essays. Payment methods are indicated during the submission process. An article will be

published once payment has been received. You may want to contact your funder about covering these costs. Many grant giving bodies have special funds reserved for APCs.

Galley Proofs: The publishers email galley proofs to the submitting authors in PDF format. Authors are requested to return the proofs with corrections to the publishers.

Reprints as pdf: A pdf file of the published article is provided to the corresponding author.

Copyright: Articles are published under the "CC-BY-NC-ND 3.0" license. This means that everyone is free to copy, distribute and transmit the published article. Commercial use is not allowed, nor are derivative works (nobody may alter, transform or build upon your work without express permission).
